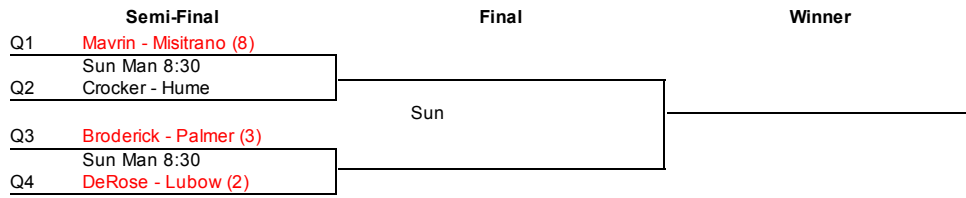

Quarter Reprive Draw



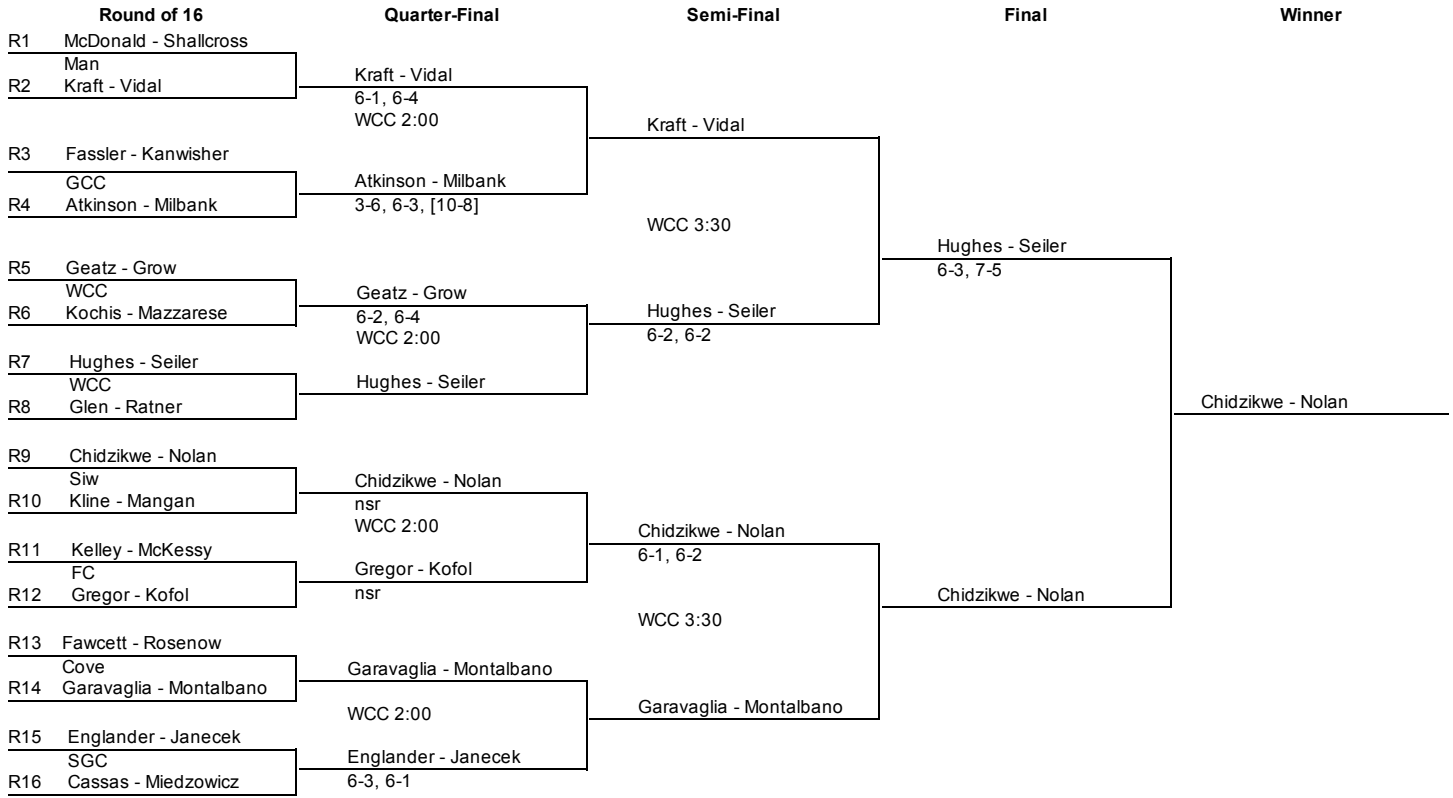
