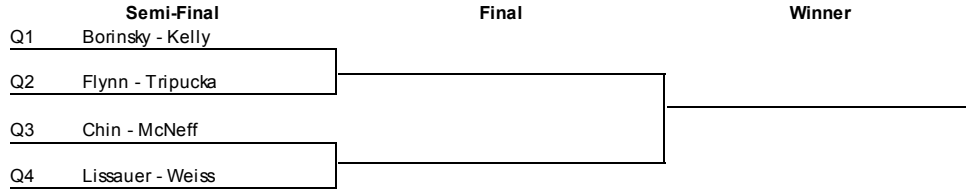

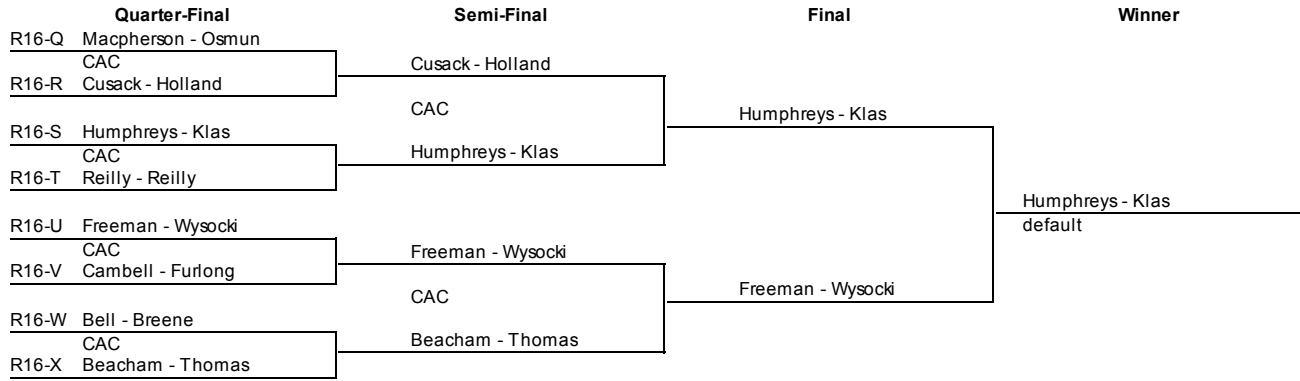

Quarter Reprive Draw



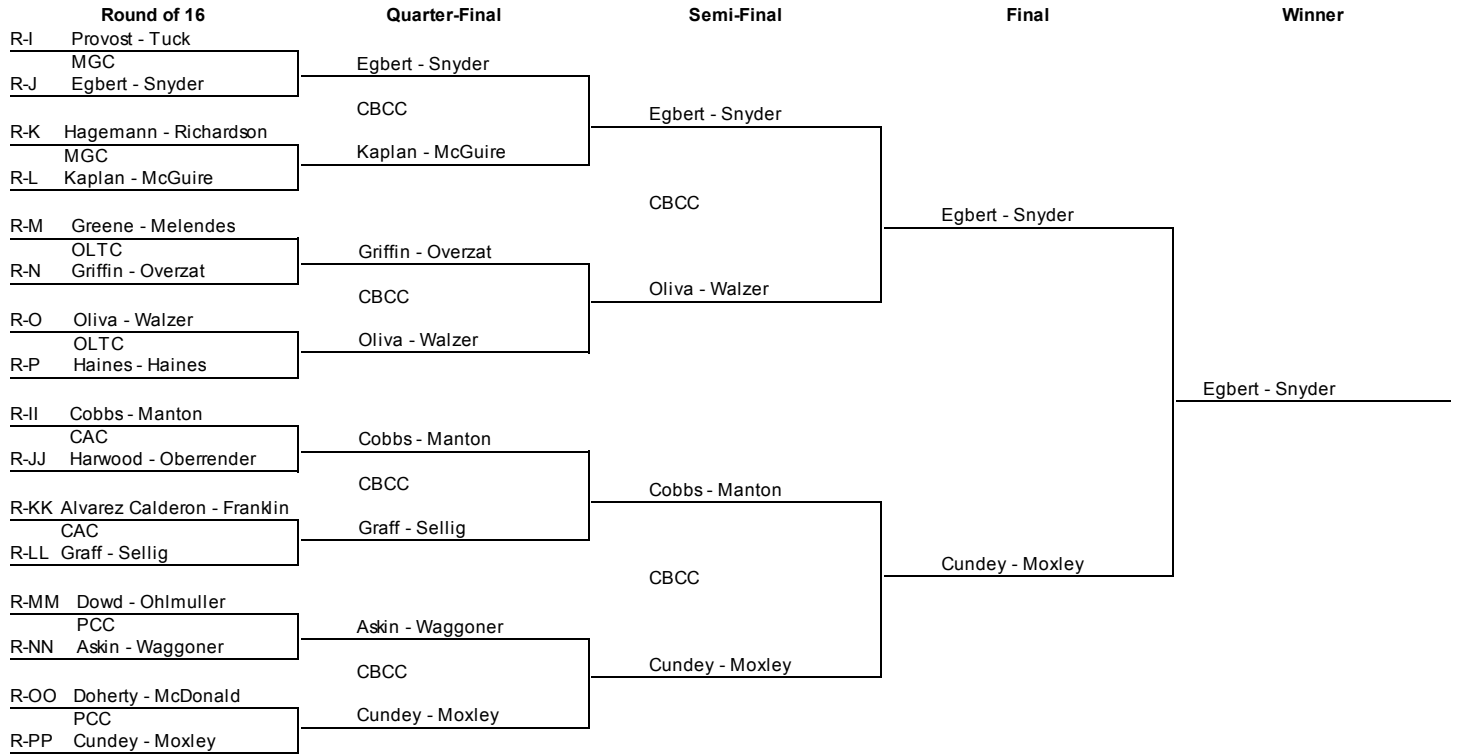

Round of 16 Reprive Draw



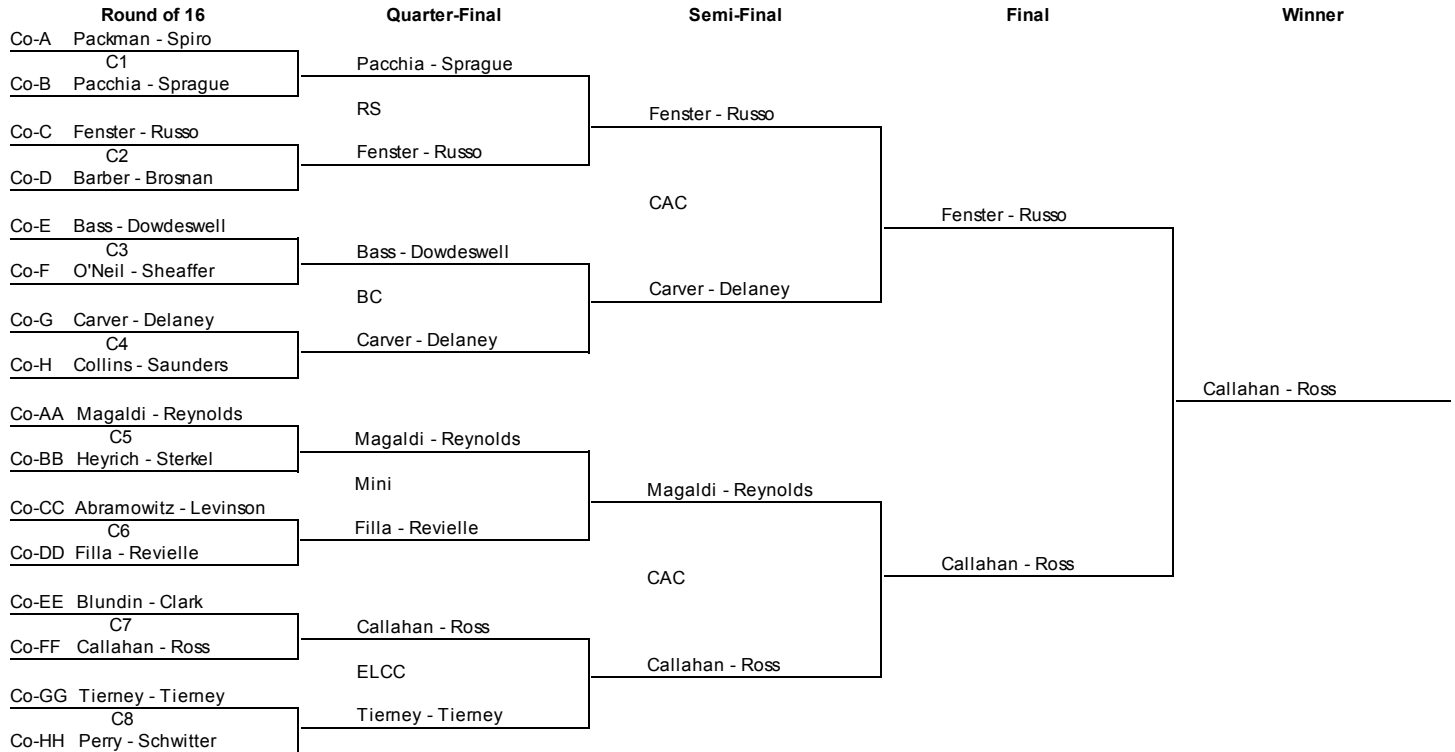
